



The area is appropriate for General Residential Zoning (GRZ) for the following reasons:

- I understand this area was zoned to its present zoning 30 + years ago and the zoning is no longer appropriate given the growth of Rangiora since then. It is within the Rangiora town boundary and has Residential zoning on the east and south sides of the area.
- Rezoning to GRZ is a logical means to increase the density in a desirable area of Rangiora without compromising productive farmland.
- Public Transport: The Bus Service route to Kaiapoi, Christchurch and beyond passes right through the area, travelling along West Belt and along River Road. There is a bus stop just to the south of the area, plus the 'Park and Drive' is only about 1km along River Road to the East.



- The rezoning with ODP would ensure there is consistent integration within the existing and new development areas including cycle and road connections.
- Examples of good connectivity for driving or cycling; close to the bridge across the Ashley River to travel North (Loburn, Sefton, Amberley). West Belt is a direct route into the centre of Rangiora, or to the South (Kaiapoi or Christchurch) or West (Cust, Oxford)
